

DBHIDS Mission and Vision



Trauma, Equity and Community (TEC)

Our commitment to addressing trauma and the lens through which we do all of work is based on the following framework:

- 1 Addressing Trauma** – transform operations to be trauma informed and trauma mitigating and to reduce traumatic experience in our systems
- 2 Achieving Equity** – transform systems to reduce behavioral health disparities and promote racial equity amongst Black, Indigenous and people of color (BIPOC) by intentionally addressing structural and systemic racism
- 3 Engaging Community** – shift services to become increasingly community based to ensure long term and sustained impacts of programs



How Problem Gambling meets the PACE and TEC framework

Engages the community to increase public awareness of problem gambling

Advocates for support services and treatment for individuals who are adversely affected

Services include prevention and education around responsible gambling in schools, community settings, and in partnership with community-based organizations






Statistics
